## SP Services - BREXIT Contingency Plans

The Department of Health and Social Care published more information to medical devices suppliers as part of its overall EU Exit continuity of supply plans.

Whilst the Government says that it is most unlikely that we will exit the EU on March 29 2019 without a deal, it is making contingency plans.

The NHS Supply Chain, for example, has begun contacting suppliers who import products from other EU countries to establish what they are doing to make sure they can continue to provide these products in a no-deal scenario.

One of the contingency measures that they will be seeking is to increase stock levels at a national level. NHS Supply Chain are now contacting suppliers who routinely import products from other EU countries to establish the action required to achieve this.

All suppliers that source products from other EU countries are asked to review their supply chains and determine what measures they need to take so that they can continue to provide products in the event of a no-deal exit.

At SP Services we not only work closely with the British Healthcare Trade Association (BHTA) but also the Government, Department for International Trade (DIT), NHS, Emergency Services governing bodies and our wider customer base, as well as our manufacturers and suppliers to ensure that we are prepared for all eventualities.

We currently hold on average 3 months stock of our most commonly used items and in some instances a 12 month stockholding for products that are sourced overseas.
